Pella Board reviews property insurance proposal

The Pella School Board will consider a property/ casualty insurance renewal proposal with EMC at its June 23 meeting. They reviewed the proposal Tuesday's at regular meeting, which includes an increase in the premium of approximately \$90,000.

Business Manager Katelyn Bierl said the bulk of the premium increase is due to the increased square footage of property protected, with the addition of the stadium upgrades and the Jefferson/Middle School Bridge (\$60,000). Pella also has the

opportunity to join the special pool offered to school districts to reduce deductibles in the event of wind/hail damage. No decision was made whether to join this pool, as the Twin Cedars School District has. Joining the pool could reduce the deductible of

\$1.6 million should the district suffer extensive wind/hail damage to \$75,000.

"There's potential savings there, that's the upside," Superintendent Greg Ebeling said.

jar of diced tomatoes will be enough. However, if you like a good amount of tomatoes and appreciate lots of juice, use a quart of canned tomatoes or a 28-ounce can. It's also possible to substitute tomato sauce for the tomatoes.

1 pound ground beef

¹/₄ teaspoon pepper 1 pint diced tomatoes

Place rice in a 1-cup liquid measuring cup and add enough water to reach the 1-cup line. Allow to stand for about 10 minutes. Mix the ground beef with the onion, salt and pepper. Drain rice and add to meat mixture. Cover with tomatoes. Bake at 350 for 45 minutes.

County The Marion Board of Supervisors met in regular session Tuesday morning. Here are a few more actions taken at that meeting.

Approved an amendment to Chapter 5 of the County's ordinances, related to Local Option Sales and Services Tax. Auditor Jake Grandia explained this was "purely administrative" and was necessary to reflect the City of Pella's vote to extend the tax for 20 years. Appointed Fallon Burney to the Commission on Veterans Affiars to fill a seat vacated with the passing of Al Van Zee. The term ends 6/30/27.

Approved a quitclaim deed for a portion of road right-of-way abandoned in the 1940s near G-40. A survey noticed the discrepancy. Plans, Approved Specifications, and

for County Line Road Pavement Rehabilitation Grading and Storm Sewer, as well as Road Pavement Rehabilitation. This will require two bid lettings, with costs shared with the City of Monroe. Both projects will have bid lettings on June 17, with an award expected at the June 24 supervisors' meeting. Approved the transfer of approximately \$19,000
