## ACCIDENT

### A BLIZZARD, A STOP SIGN, A SNOWPLOW, 2 VEHICLES — AND A CRASH

The Clay County Sheriff's Department investigated a two-vehicle crash that occurred Wednesday, Jan. 21, at 2:05 p.m., at the intersection of 400th Street and 130th Avenue, about 2 miles west of Royal in Clay County. According to a report from the sheriff's department, it was determined that Jerry Wise, 55, of Ayrshire, was driving his 2011 Cadillac DTS northbound in the 4000 mile of 130th Avenue when he failed to see the stop sign at 400th Street during a ground blizzard. Wise entered the intersection and was struck by a 2023 Chevrolet Silverado 1500 driven by Eric Walhof, 50, of Spirit Lake, who was leaving the eastbound stop sign on 400th Street. Walhof's view to the south was blocked due to a Clay County Secondary Roads plow and did not see Wise failing to slow down. Damage to the Wise vehicle was listed at \$5,500 and damage to the Walhof vehicle was estimated at \$6,000. No injuries were reported. Wise was cited for failure to obey a stop sign and failure to provide security against liability (no insurance) — accident related.

## ARREST

Angel Kent, 45, of Marathon, was arrested Friday, Jan. 24, at 4:50 p.m. in the 1400 block of Fourth Avenue SW in Spencer and charged with driving while under suspension, no driver's license and no insurance, all simple misdemeanors. A report from the Clay County Sheriff's Office stated a Clay County Sheriff's deputy initiated a traffic stop with having prior knowledge the driver, Kent, had a suspended driver's license. Upon making contact with Kent, she was placed under arrest and transported to the Clay County Jail without incident. Kent was released on bond.
